- 6. Fair, consistent, equitable practices in resolving school and community conflicts.


The argument for elementary schools

AEL Workload Committee Priority: Elementary Schools

The elementary schools of Anne Arundel County exist to build the strong foundation for student success in meeting the national goal of college and career readiness.

For many years elementary schools have been the stepchild of this system with additional staffing and priorities allocated to middle and high schools. Both middle and high schools have a variety of nonteaching positions to support instruction, enhance programs, refine teaching strategies and provide collaboration with principals. There are AYP coaches, nonteaching Department Chairs in most core areas, Special Education Facilitators, Academic Coaches, IB Coaches, Literacy Coaches, Staff Developers, Business Managers and Test Coordinators. Again, all of these nonteaching supportive educators have been assigned to Middle and High School. Most of these valuable resources do no exist at the elementary level. To add to this, every secondary school has more than one assistant principal and more than one guidance counselor.

The question at hand for the 2014-2015 school year is: where is the equity in staffing resources in your elementary schools? There is a wealth of research from almost every higher academic center citing the value of early childhood intervention services, yet this research continues to go unheard in Anne Arundel County with minimal resources to our youngest learners.



Sick Leave Bank Vote

The sick leave bank is currently running short, the appropriate number of sick days to cover members for the 2014-2015 school year. The Committee is proposing that each AEL member be assessed one sick day on July 1, 2014. This will restore the bank to solvency and meet members needs in the future.

A vote on this proposal will occur at the June meeting which will be held at the Severn Inn on June 5th at 5:00 p.m.

hat AEL is a permanent part of the educational and union landscape and can serve its members from a fixed location. In other words, AEL is here to stay.

As part of the comprehensive plan, AEL is reaching out to civic and business organizations. In the upcoming months, AEL will apply for membership in the Chamber of Commerce and the Rotary Club. By becoming a part of these community organizations, AEL can bring its message to those who can lend support to the educational system by showing them the value that a strong and effective school system is a result of effective school based administrative leadership.

It has become very clear that AEL can no longer operate in a vacuum. While our participation in the Coalition is helpful in some collective bargaining areas, it is not a substitute for finding others to champion our cause and support our message. For years the term "Administrator" has been erroneously linked to upper level Board of Education Administration. The public must be made aware that Unit II employees are not, in fact members of the educational bureaucracy at Riva Road. As this bureaucracy grows and expands, it does so at a cost to our members. Because funding is finite, for every dollar requested and received to support the growing staff at Riva Road clearly impacts to the detriment instructional personnel and programs. This translates into less school administration help, longer working hours and increased workload for Unit II employees with stagnant or less pay for the tasks required. You are working longer

and harder for fewer dollars that can't keep pace with inflation.

AEL believes that by reaching out to these business/civic groups and becoming a member, it can make the public understand that dollars "properly spent" on educational programs and appropriate compensation for those who administer the same are vital to a strong school system and a strong school system is vital to a strong community. You encourage economic growth by being able to demonstrate to businesses and developers that the school system is a value added component. People move here and want to work here if they are convinced that educational dollars "properly spent" will enrich the educational process. "Properly spending" on education must include fair and adequate compensation to AEL members as negotiated, promised and agreed to out of respect for the services they provide in this educational enrichment process. Unfortunately, this is a message and a banner AEL can no longer carry alone. The funding authorities need to hear from these groups. Pressure now needs to be brought through many voices. AEL believes its participation in organizations like the Chamber of Commerce and Rotary will assist it in delivering the message, which is consistent with the mission of these organizations as well.

As the Executive Director and General Counsel for the Association of Educational Leaders ("AEL"), I am writing to express AEL's disappointment in not being included, by representation, in the Superintendent Selection Committee. While AEL acknowledges that the ultimate decision to employ the superintendent is vested in the Board of Education, we believe that AEL's participation on this committee would have provided very valuable insight and help in your ultimate selection.

By representing all Unit II employees who provide school-based management for the Anne Arundel County Public Schools ("AACPS"), AEL's wealth of information and perspective could have been shared with the Board and potential candidates in a collaborative manner. While AEL did not expect to be a part of the decision, it should have been part of the process beyond the mere general discussion of qualifying characteristics with the hired outside placement company. We believe that the Board, by not inviting this participation, lost a very unique opportunity to hear from AEL and use that on site information to assist in qualifying and selecting a superintendent who would be compatible with the needs of this school system.

AEL remains committed to supporting the mission and vision of the Board of Education and the new superintendent. We must all work in unison to sustain "Excellence in Education."

AEL Vice President addresses the County Council

Nelson Horine's remarks to the Council on May 12

hairman Grasso and members of the county council, for the record my name is Nelson Horine. I am a long time resident of Anne Arundel County and a 45-year employee of Anne Arundel County Public Schools. I am currently the Principal of Anne Arundel Evening High School, and Vice President of the Association of Educational Leaders.

AEL represents school based administrators and coordinators, and is the only non-affiliated union in the county with over 275 members representing approximately 80 percent of the eligible Board of Education Unit II employees, most of whom are county taxpayers.

AEL is committed to providing the finest educational delivery system for the county's school children and we are also committed to the collective bargaining process. Strong, dedicated administration in our schools is essential in order to maintain the highest standards of education for our county.

Retention of our administrators should be one of our highest priorities. Their institutional knowledge is vital to the success of our school system, especially in this time of vast changes in the approach to educating our students. We cannot afford to lose our valued administrators to other counties, or to retirement, not because they need and deserve the rest that awaits the end of a career, but because it is no longer financially sensible to continue to remain employed by Anne Arundel County Public Schools

When examining the Board of Education's budget please appreciate that instructional costs that include fair, appropriate, and negotiated salaries are an essential part of the educational delivery system.

Please remember that compensation for administrators is not based on a 40-hour work week. Many hours are spent well beyond the school day. Federal and state mandated programs without corresponding funding have increased administrative workload without corresponding compensation.

Salaries and compensation have been fairly negotiated with the school system, but recently underfunded. Our members are taxpayers who in a very real way fund their own pay raises. If school system employees are expected to have faith in the negotiation process, the agreements reached as a result of this process need to be honored.

A community that wishes to remain strong and vibrant and encourage new economic growth is judged on the strength of its school system.

Passing a fair and equitable budget that takes into account the need for a strong and productive school system is an investment in everyone's future in Anne Arundel County.
